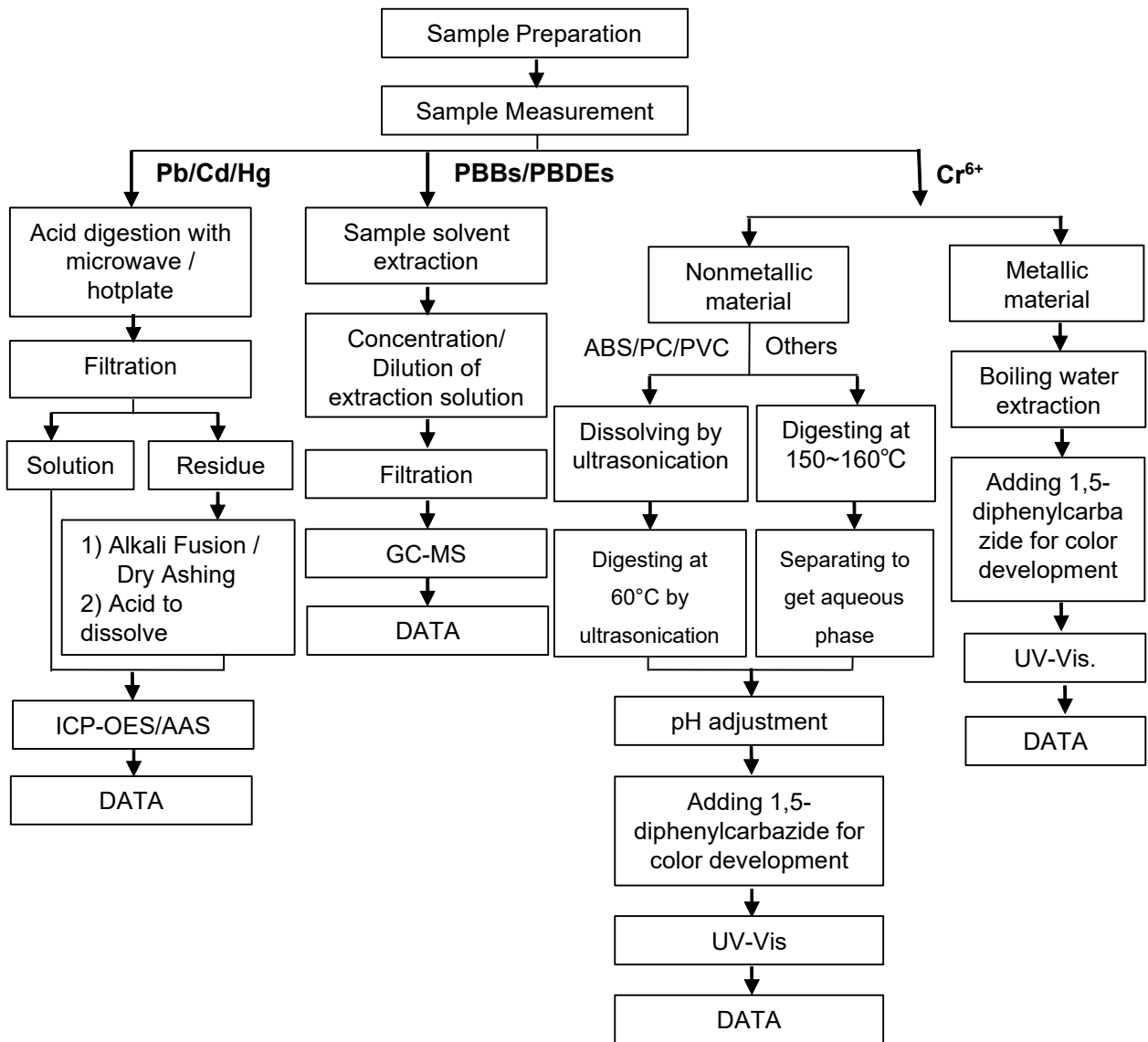

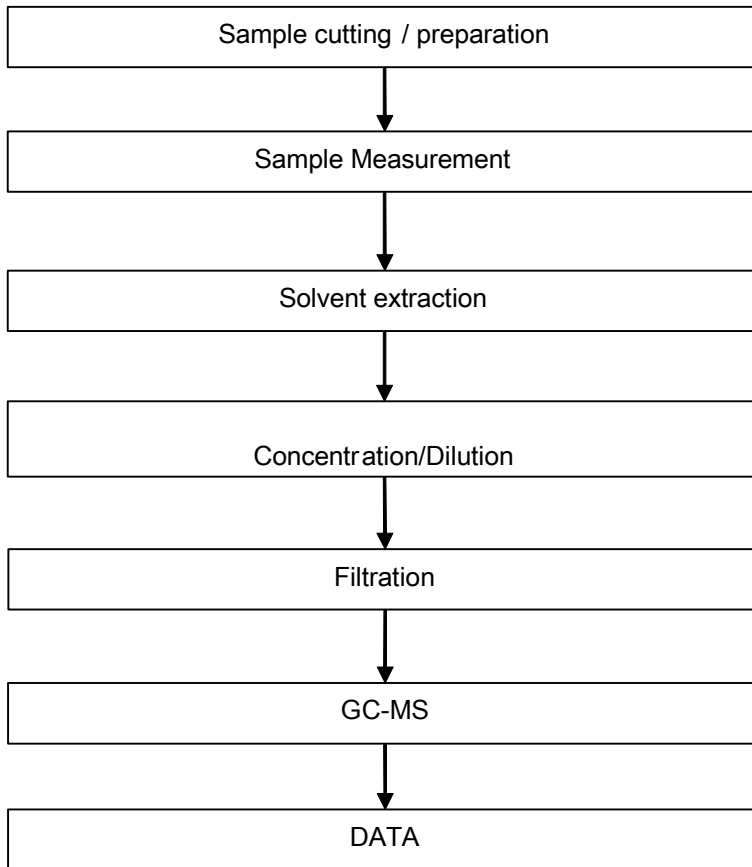

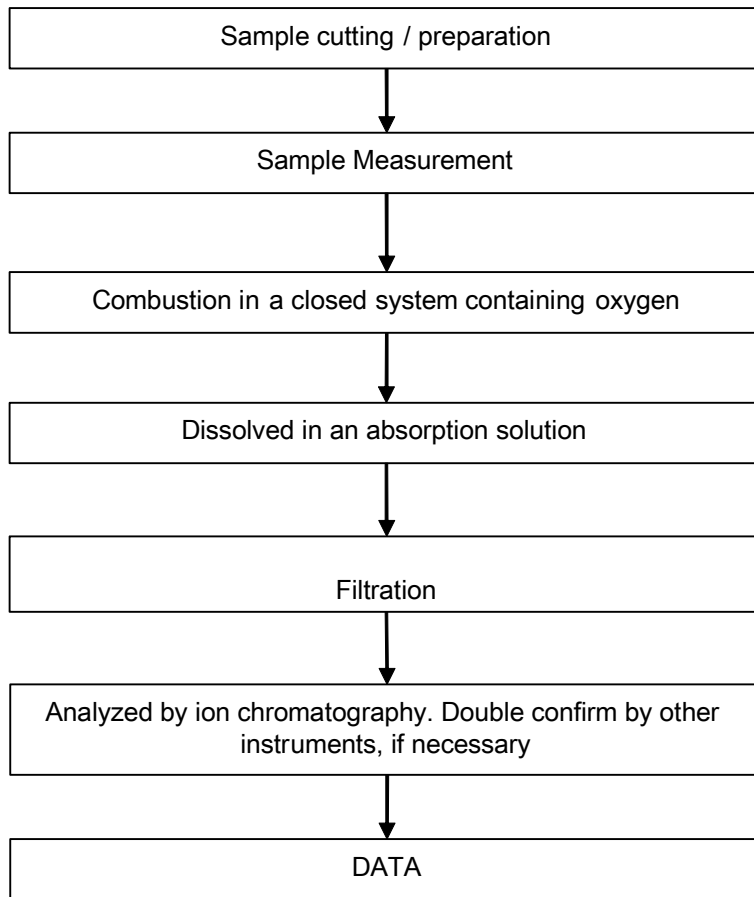

Halogen Testing Flow Chart

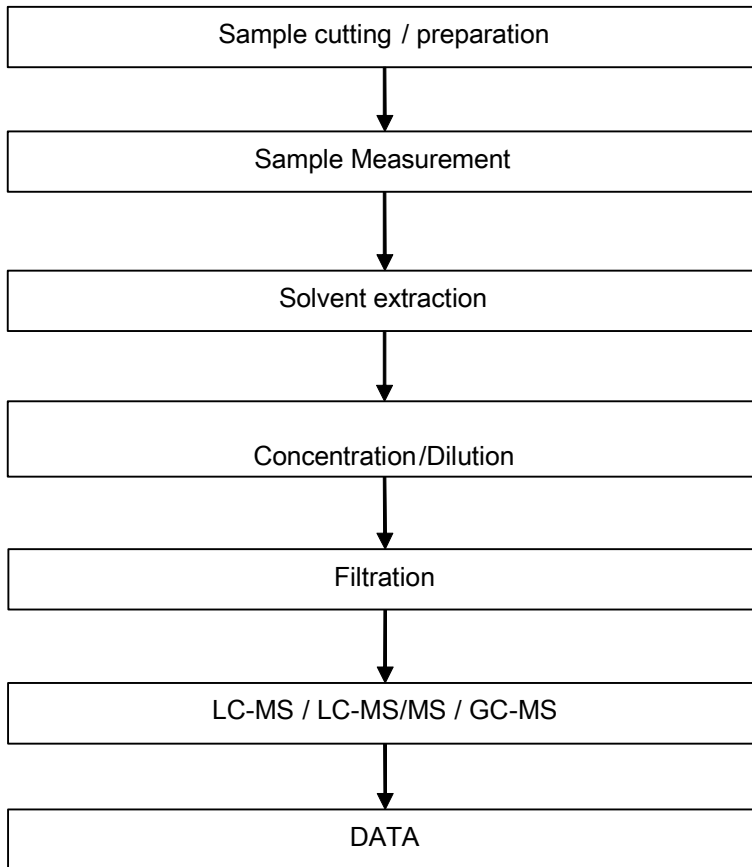

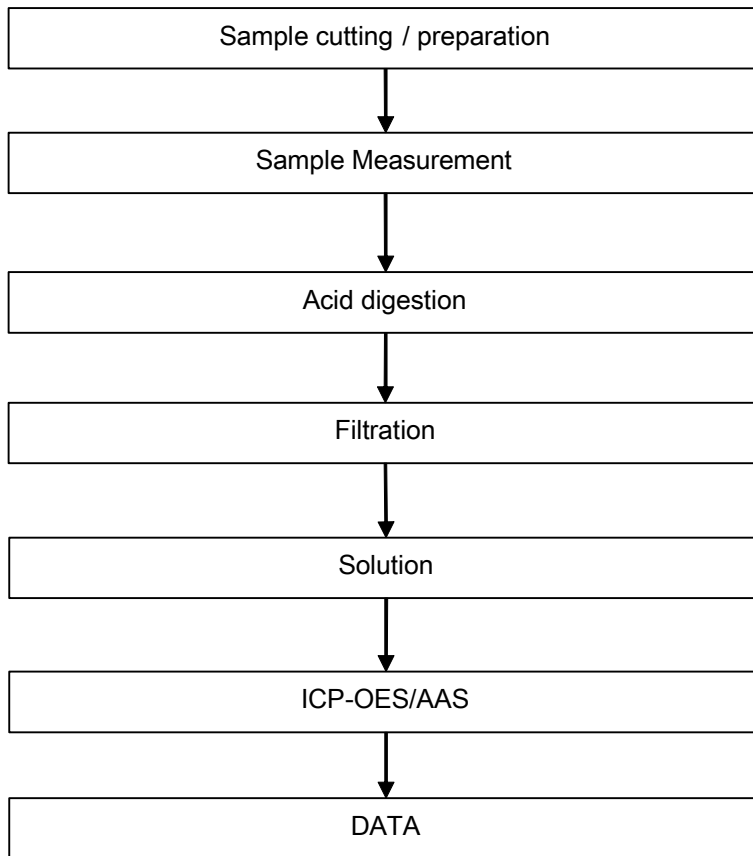

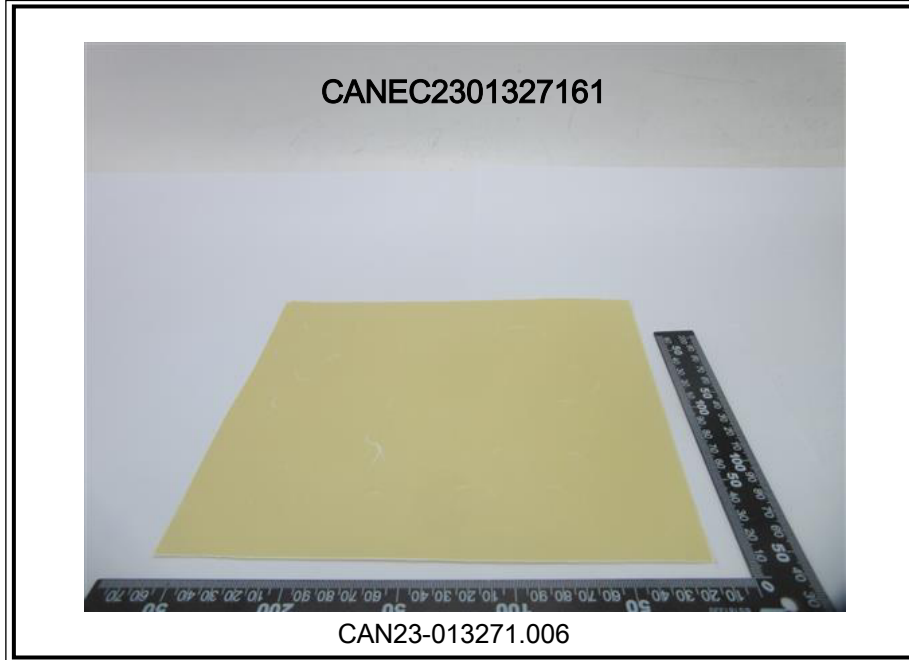
